ITEM/ HAZARD	CONTROL MEASURES
Bushcraft knives	<ul style="list-style-type: none"> ▪ Clear Safety Briefing and guidance on how to use the tool with emphasis on always cutting away from the body. ▪ Participants are to be made aware of others around them, and must not work any closer to anyone than the length of their arm plus the length of their knife. ▪ Dedicated work area highlighted at the start. ▪ Knives must be sheathed at all times when not in use. ▪ Introduce a 'STOP' Command. ▪ Close supervision at all times. ▪ Knives only to be used while seated or kneeling unless using a chopping block or board. ▪ If standing then the workpiece must be resting on a chopping block or board. ▪ Tools to be stored in a locked box and only issued when necessary and collected after use. ▪ Safety equipment to be used when needed. ▪ First Aid kit present.
Bow saw	<ul style="list-style-type: none"> ▪ Clear Safety Briefing and guidance on how to use the tool. ▪ Gloves on non-sawing hand. ▪ If the back of the blade is free from sharp burrs and edges, Place brace hand through the saw until the blade is fully embedded in the wood. ▪ QUESTION: Where will the blade go if it slips? ▪ Start sawing gently, increasing pressure once the saw has developed a groove. ▪ Safe working distance. ▪ Blade to be covered when not in use. ▪ First Aid kit must be present.
Folding saw	<ul style="list-style-type: none"> ▪ Clear Safety Briefing and guidance on how to use the tool. ▪ Gloves on non-sawing hand. ▪ QUESTION: Where will the blade go if it slips? ▪ Safe working distance. ▪ Blade to be covered when not in use. ▪ First Aid kit must be present.
Axe	<ul style="list-style-type: none"> ▪ Full instruction and close supervision provided to participants that have not used axes before. ▪ Supervision maintained for all. ▪ Axes kept sharp and handles regularly checked for cracks/damage ▪ Axe work to take place in specified area only. ▪ Maximum group size of 6.



	<ul style="list-style-type: none"> ▪ Bystanders remain at a safe distance outside the cutting area.
Transportation and storage	<ul style="list-style-type: none"> ▪ All knives kept sheathed / closed when not in use. ▪ Knives kept in a locked box when not in use. ▪ All saws blades kept covered when not in use.
Further risks	<ul style="list-style-type: none"> ▪ All risks should be minimised by continual appraisal of participants' condition, the environment and equipment through dynamic risk assessment by the staff members involved. ▪ Some risks still remain but every care must be taken to minimise these.
